## FOOD TRUCK AND PUSH CART ACKNOWLEDGEMENT FORM

By signing and submitting this form I acknowledge that:

1. I have received written consent from any owner of private property of the proposed location of my food truck or pushcart.
2. My mobile food truck or pushcart will not occupy on-street parking spaces.
3. I shall meet and obey all parking and traffic laws.
4. My mobile food truck or pushcart is not parked in any ADA accessible parking spaces.
5. My mobile food truck or pushcart is parked on a paved or all-weather surface or other approved material.
6. Any parking spaces that are occupied do not obstruct parking for the principal use of the property.
7. My mobile food truck or pushcart will only be located in a public right-of-way if I have provided the location, time and date to the Town and I have received an approval letter from the Town. My food truck or pushcart will be located within a right-of-way in accordance with the Town Code.
8. All refuse generated from my mobile food truck or pushcart has been properly disposed of.
9. Sidewalks, roadways, and other adjacent spaces are kept clean and free of any refuse.
10. I understand that no additional structures, canopies, tables, or chairs are allowed.
11. All signage is affixed to the food truck or pushcart except during hours of operation.
12. When vending in a public right-of-way, vending will occur from the curb side.
13. As a food truck or pushcart operator, I will not obstruct pedestrian or bicycle access or obstruct parking lot circulation or impede traffic.
14. My food truck or pushcart will be closed at the end of each business day unless otherwise approved.
15. Any food truck or pushcart license shall be good for up to one (1) year from the date licensed.
16. If I wish to renew my food truck or pushcart license, I will provide an application and notice to the town later than 10 business days before the expiration of my current license.
17. My food truck or pushcart license will be displayed at all times.
18. My food truck or pushcart license may be revoked immediately if found in violation of Town Municipal Code and may be denied a future food truck or pushcart license for one (1) year.
19. All information provided on and with my application is true and accurate to the best of my knowledge and any false information may result in a delay, denial, suspension or revocation of my mobile food truck and pushcart license.
