Kiowa Sidewalks and Drainage Project and Kiowa Bridge Replacement

Both are in the engineering and design phase at this time with construction expected to begin Spring 2025. Both are anticipated to be 3-year projects.





With school back in session, we need to be aware of children going to school and follow all the rules. But how about children and adults doing their part?

Vandals have been stealing the sprinkler heads off the Town sprinklers in Nordman Memorial Park and damaging the sprinkler lines and costing the Town unnecessary repair costs. We need your help in identifying these criminals.

Municipal court is now back in session in Kiowa. The first court docket will be held on Wednesday, October 8th at 9am, here at Town Hall (404 Comanche Street). If you have received a pink summons from code enforcement, please heed the date on that summons and appear accordingly to avoid any unnecessary, escalated action on your part.

Judge Paul King retired in 2018 after serving for 18 years as a District Court Judge in the 18th Judicial District. Currently, he also serves as municipal court judge for the towns of Hugo and Limon.

Kiowa Water and Wastewater Authority (KWWA) happenings!

The Authority is a not-for-profit municipal water and wastewater provider and due to this KWWA raises rates only when absolutely necessary. Continued increases in the costs to deliver safe, reliable water have prompted KWWA's board of directors to approve changes to the Authority's rates and regulations that took effect with a 9 % increase on the September 2024 bills. The new base rates are as follows:

> Residential - \$115.43 Commercial - \$136.39 Government - \$156.10 School - \$151.55

As part of the changes, KWWA customers will see another rate increase of 3% again on the February 2025 bill to meet the start of January's water use.

Have you seen the blue signs at the hydrants? Those signs mean the fire hydrants in your area are slotted for blow out and the signs will tell you when. There are 50+ hydrants in Kiowa so this process is being broke up in three sections. Be assured these blowouts will not affect your water delivery or quality in any way.

Temperatures are dropping and winter is coming! Make sure you winterize your sprinkler systems. Also, examine leaky exterior faucets, as well as in the kitchen, bathrooms, and utility rooms. Time spent now to address drips will cost considerably less than a broken/frozen pipe in winter. Disconnecting hoses helps prevent frozen pipes and can eliminate emergency repairs! Unauthorized tampering with KWWA District systems and/or meters is illegal and will result in a fine of not less than \$2,000 per incident, in addition to the actual cost of damage, expense, and loss of the systems and/or meters.
