Planning Commission Commissioner Application

The Town Planning Commission shall be appointed by the governing body, all of whom shall be residents of the locality, qualified by knowledge and experience to make decisions on questions of community growth and development. Members so appointed shall be owners of real property within the Town of Kiowa.

Qualifications for Town of Kiowa Planning Commission:

1. U.S. Citizen;
2. Not connected with any other town department or commission;
3. Must have knowledge of physical and economic conditions of the town and the purpose and scope of town planning;
4. Registered elector of the Town of Kiowa;
5. Resident of Kiowa for a period of no less than twelve (12) consecutive months preceding the election;
6. Never convicted of a felony; and,
7. Not an employee of the Town of Kiowa.

Commissioners are expected to:

1. Endeavor to align their behavior, actions, and decisions with these principles of good governance. Thus, each Commissioner should adhere to and be committed to the Town of Kiowa's Board of Trustee Code of Ethics.
2. Have regular attendance at monthly meetings held the third Wednesday of every month at 6pm at Kiowa Town Hall, and all special meetings, scheduled as needed.
3. Be an active member of the Town. This means having regular participation in training events, town events, and fundraising efforts.
4. Comply with applicable current state law, concerning conflict of interest and disclosure requirements, including but not limited to C.R.S. 24-18-10 et seq., C.R.S. 31-4-404, C.R.S. 24-18-201, C.R.S.18-4-301, C.R.S. 18-4-401, and C.R.S. 18-8-308.
5. Satisfy in good faith your obligations as citizens, including all just financial obligations, especially those such as federal, state, or local taxes that are imposed by law, and all water and wastewater obligations to the Kiowa Water and Wastewater Authority (KWWA).
6. Promote the Town to colleagues and community in a positive and respectful manner.
